Envelopes/transactions containing entries for more than the ten (10) dog maximum and/or entries received prior to the opening date shall be treated as an invalid entry and shall be returned to the sender. **Day of Show entries will only be accepted if the trial does not fill with pre-entries.**

SARS-CoV-2 CONSIDERATIONS (COVID-19)

READ CAREFULLY! THESE RULES WILL BE ENFORCED!

We are experiencing a very difficult time in our lives with the novel coronavirus pandemic sweeping through the world. We are confident that following these rules will allow us to have a safe and fun experience during these tests. Please take these into consideration before you enter. If you cannot follow these rules you will be asked to leave the show grounds and your entry fees WILL NOT be refunded.

1. **Masks Are Required!** - You will not be allowed on the show grounds unless you wear a mask. You will not be allowed to run your dog unless you wear a mask. Please make sure your dogs are accustomed to you, and others, wearing masks. This can be strange for some dogs.
2. Keep a physical distance of at least 6 feet (2 meters) from all other people at all times.
3. Please give each other room and keep apart when getting ribbons.
4. Hand Sanitizer will be provided by the club. However, you are encouraged to bring your own.
5. If a judge is unable to come to the trial, or if we lose a location, entry fees for that judge/element/location will be refunded.
6. If you test positive for COVID-19 prior to the trial and need to pull, entry fees will be refunded less the AKC processing fee.

PRELIMINARY RUNNING ORDER

Due to the COVID19 pandemic, and In order to lessen the number of handler/dog teams on the grounds at one time, the tests will be run concurrently. This means the running order will be designed to have teams run in groups of approximately 4 dog/handler teams at a time. Once you have run under one judge, you will have a short break (of approximately 10 minutes) then you will run under the second judge. If you have multiple dogs you will be given enough time to have a break between dogs. A detailed running order will be emailed out by the trial secretary a few days before the test. This will be for both the FDC and the ATT on Saturday. Considerations will be made for those entering both.

TEST DETAILS

- **Test Grounds Open at 8:00 AM.** Please DO NOT ARRIVE prior to 8:00 AM. This location is at a personal small family farm and we need to be respectful of the family living there.
- **Running Order:** A running order will be available in the final confirmation email which will be sent out a couple of days before the test. Exhibitors are allowed to enter more than one dog.
- **Crating:** Please be prepared to crate in your car.
- **Ribbons:** A flat green ribbon will be provided for each qualifying run.
- **A title pin** will be provided to those dogs who pass both legs with a qualifying score.
- **Livestock** to be used will be sheep and chickens. There will be approximately 10 penned chickens and 3 sheep.

NOTICE TO EXHIBITORS

DOGS ELIGIBLE TO ENTER

1. **The Farm Dog Certification** is open to all dogs at least 9 months of age that are individually registered with the AKC, dogs with PAL numbers, and dogs enrolled in the AKC Canine Partners Program. Dogs in Misc/FSS are also accepted.

 - b) All dogs must wear a flat buckle collar as per AKC FDC rules. No harnesses, choke chains, gentle leaders, or other types of gear is allowed during the test.
2. **The AKC Temperament Test** is open to all dogs at least 12 months of age that are individually registered with the AKC, dogs with PAL numbers, and dogs enrolled in the AKC Canine Partners Program. Dogs in

Misc/FSS are also accepted,.

- b) Dogs with disabilities such as those that are blind, deaf, or have three legs are eligible to enter provided in the opinion of the evaluator they display no signs of physical discomfort and can safely complete the test. However, if a dog has multiple disabilities such that, it is unable to complete whole categories of the test (i.e. - hearing auditory stimuli and seeing visual stimuli), the dog would not earn the ATT title.
- c) Dogs may wear slip collars that are on the dead ring, buckle collars, martingales and body harnesses in the ATT. They may not wear prong collars, head collars, ecollars, or harnesses that restrict the movement of the dog. Leashes should be 4ft. to 6ft. long and should be made of fabric or leather

ADDITIONAL INFORMATION

1. For Exhibition Only entries will not be accepted.
2. If you do not receive an email confirmation a week after you send in your entires, please email the secretary at secretary@pawtap.net to verify that your entry has been received.
3. Dogs **MUST BE ON LEASH AT ALL TIMES!** This is an AKC rule. Off-leash dogs will be excused and required to leave the show grounds. No refunds will be given.
4. According to AKC, Bitches in season are not allowed.
5. Healthy Dogs Only. If your dog shows any signs of ill-health, such as coughing, the dog will be excused and required to leave the show grounds. No refunds will be given.
6. Weather: These tests will be held at an outdoor location. Please be advised that the weather in Utah can be unpredictable. If a major storm or heat wave is expected, we reserve the right to cancel the test. If the test is cancelled due to weather, full refunds will be issued. Email information will be sent out the day before if there is any concern about the weather.
7. You **MUST** clean up after your dogs! If you are found not picking up after your dog, you will be excused from the test and required to leave the show grounds. No refunds will be given.
8. Refunds will only be given for entries pulled before the closing date. After the closing date, no refunds will be given unless you suspect you have been infected with COVID19. This includes injuries (of person or dog). If you are not feeling well and think you may be sick, contact the show secretary and a refund will be provided.
9. Any entries may be declined for cause and may be refused; the test committee remove any dog on account of disease, viciousness, or other causes, and no one shall have any claim or recourse against the committee or any official thereof.
10. Entry fees shall NOT be refunded in the event that a dog is absent (unless replaced by an alternate), disqualified, excused by a veterinarian, judge or tester or barred from competition by the Test Committee. Any dogs aggressive to persons or stock will be removed. (See Chapter 1, Section 22 of the American Kennel Club Herding Rulebook.) If, because of riots, civil disturbance, or other acts beyond control of the Club, it is impossible to open or complete the show, no refund of entry will be made. Dogs must be ready for their classes. Test/Trial judges have the authority to refuse to judge any dog that does not appear within five minutes of being called for its run. The Test/Trial-giving Club and the Test/Trial Secretary have no obligation or responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

INFORMATION REGARDING THE FDC AND ATT TITLES

In order to receive the FDC and ATT titles from AKC, the dog must past each test two times, under two different judges. In order to receive the tiles from AKC, the exhibitor must also apply for the titles through AKC. Results will be sent to AKC, but in order to have the title sent to you, you need to send AKC \$25 and the following application form
