ENTRIES CLOSE ON May 27, 2023 at 6 PM MT and must be received by that date/time at the trial secretary's address, after which time entries cannot be cancelled, altered, or substituted except as provided for in Chapter 11, Section 6 of the Rules Applying to Dog Shows. Envelopes/transactions containing entries for more than the ten (10) dog maximum and/or entries received prior to the opening date shall be treated as an invalid entry and shall be returned to the sender. Day of Show entries will be accepted for element runs if the trial does not fill. The following hard close will be enforced: No changes due to move-ups, pulls, or wait-listed entries will be accepted after June 7, 2023 at 5:00 pm.

DOGS ELIGIBLE TO ENTER

This trial is open to all dogs SIX (6) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), or an AKC Canine Partners listing number. Approved Foundation Stock Service (FSS) breeds are eligible to participate. Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Dogs with physical challenges (including amputees) are eligible to participate provided that, in the opinion of the judge, the dog displays no sign of physical discomfort and can safely complete the search. Deaf and blind dogs are allowed to enter. Females in season may not participate, aggressive dogs, or dogs suffering from an injury, or illness which may affect the dog's physical or mental performance may not participate. No dog shall compete if it is sutured, bandaged, or has any visible wounds.

WAIT LIST INFORMATION

The Bristle Nose Scent Work Club of Utah is offering a wait list to fill openings created by withdrawn entries after the trial's closing date. All pre-entries, including wait listed entries, must be received by the trial secretary prior to the closing date at the trial secretary's address. No entries may be withdrawn with a refund after closing date. Any wait listed entry that does not move off the wait list into the trial will receive a full refund. No wait listed entries will be changed or modified after the hard close date (listed on first page).

CRATING, STAGING AREA, HANDLER'S BRIEFING, AND WARM-UPS

Crating will be in competitors' cars. More information will be provided in the final email confirmation.

The **Staging Area** will be out of view of search area(s). The Staging Area will include a warm-up and waiting area, as well as the secretary table for check-ins and posting of running order and results.

The **Handler's Briefing** will take place in view of the search area prior to the start of each class. In the Handler's Briefing, the judge will explain off-leash options and maximum time for the search. NO DOGS are to be present during the Handler's Briefing.

A **Warm-up Area** will be available consisting of ONE marked container of each odor being tested at the trial and may also consist of blank containers. Exhibitors should limit their warm-up to (2) two minutes or less. The warm-up area is to be used exclusively for warming up the handler-dog team prior to their run, or for recovery after the run. The warm-up area is not for training or relieving of the dog.

SEARCH AREA INFORMATION

Searches will be indoors. Walk throughs will be provided before each element so handlers will be able to see the search areas.

Search areas, potty areas, and walking paths might include uneven ground or changes in elevation, and might be located a distance from the competitor waiting area.

EXHIBITOR INFORMATION

SAFETY, BEHAVIOR and LIABILITY

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made.

The safety of the dog is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all searches safely. The Bristle Nose Scent Work Club of Utah (BNSWCU) and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assume no responsibility for injury to children. BNSWCU reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the Bristle Nose Scent Work Club of Utah or any official thereof.

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

Collars, Leashes and Harnesses. During searches, dogs must wear a properly fitted collar or harness approved by the judge. A wearable camera such as a Go Pro may be mounted to the dog's harness, if desired. Leashes may be of any length and/or retractable. The leash should be made of plain, pliable material. All dogs must be on leash at all times, and retractable leashes may not be used when on trial grounds (except during judged searches). Dogs must enter and exit the search area with the leash attached to the collar or harness, including when waiting in the search area before and after the search. An off-leash option may be offered at the discretion of the judge, only if the area is completely enclosed.

Trial Site. It is not appropriate to scout the trial location prior to the trial date. Many search locations are real-life environments and such visits may risk the host losing the opportunity to use the location in the future.

Possession of Odors and Training. Chapter 5. Section 26 of the Scent Work Regulations state “No person other than those engaged in the administration of a trial shall be in possession of any target odor when on the trial grounds. There shall be no training on the grounds of the AKC Scent Work trial, other than the designated warm-up area.

Spectators. Spectators are encouraged. Handlers may not watch other exhibitors from their class prior to their run. Spectators are forbidden to discuss details of the search until the completion of the class.

Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds.

Assisting: No one outside the search area may assist the handler or disclose the location of the hide. Spectators who intentionally or unintentionally give aid to a team may be ask to leave the area by the judge AND THE ENTRANT WILL RECEIVE A NON-QUALIFYING SCORE.

Videoing of runs will be allowed. However, if you are found to upload videos of your search to social media before your element/level is complete, you will be reported to the AKC for the violation.

REFUNDS

If you are feeling ill and think you may have contracted COVID19, your entry fees will be refunded, minus the \$3.50 AKC processing fee. You must notify the secretary no later than the night before to receive a refund. In all other cases: no entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee. Dogs pulled after closing because of injury or other medical condition may be eligible for a refund, please contact the trial chair. Bitches in season will be refunded entry fees less the AKC processing fee. Notification in writing must be given to the trial secretary no later than the hard close date listed on the first page.

RINGSIDE

Judges are not required to wait for dogs. The Owner of each dog is solely responsible for having it ready at the search area when it is to be judged. The Club has no responsibility to provide service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

Exhibitors MUST check-in EACH day they are entered.

Claims will be arbitrated as set forth on the official AKC Entry Form for this event.

VENDORS

There will be no food or beverages for sale on the trial grounds. No professional photographer will be available for photography services. No commercial sales will be allowed on the show grounds during the weekend.

AGREEMENT

I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. I (we) certify and represent that the dog entered is not a hazard to persons or other dogs. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim of loss, injury or damage to this dog.

Entrants are responsible to be familiar with AKC Scent Work rules. Novice A Classes are open to dogs who have not completed any title for that particular element, who have not completed a comparable title with another organization, and who have never worked as professional detection dogs. Novice B classes is open all dogs. Dogs may enter multiple dogs in different levels within each element (with the exception of Handler Discrimination), at each trial. Multiple dogs from the same owner may be entered in the same class/level, provided they are run by different handlers. Dogs entering the Advanced, Excellent, Master or Detective classes must have earned the required title, as stipulated in the AKC Scent Work Regulations. To be eligible for the High in Trial award you must be entered in all elements (Interior, Exterior, Interior, and Containers), in the same class, for that trial.
